

NetP Policy Critique Marking Criteria:

Identify a policy or procedural guideline that is currently used within your nursing clinical environment and critique its usefulness against current evidence based practice, discussing how this promotes best practice. From this critique you are then expected to generate recommendations that can be used to inform future practice; and share the information you have learnt with your colleagues within your clinical environment.

- Discuss your choice of policy or procedure with your nursing line manager for relevancy, prior to commencing this assignment.
- Use the following instructions and the marking guide as a framework to develop your assignment:
- The cover page is to be submitted as part of the assignment or it can be submitted as a separate document. Your executive summary, policy/procedure critique and reference page are to be submitted electronically as ONE document.

Executive Summary:

This is a summary of your policy/procedure critique. It will be used for review by the Directors of Nursing Canterbury and West Coast regions. The Executive Summary is one single-sided page, to include:

- Your name, workplace, topic of the policy/procedure
- A short overview of your findings under the heading 'Outcomes of Policy Critique' (one paragraph)
- A summary of your recommendations under the heading 'Recommendations' (a paragraph or bullet-points is fine). Please include the same recommendations that you have identified in your policy/procedure critique.

Policy/Procedure Critique:

 Word Limit: 2000 (+/- 10%) This word limit does <u>not</u> include the Executive Summary nor the Reference page of your assignment

Line Spacing	1.5 or double spaced
Page layout	Single sided
Margins	2.5 cm on the left , 5 cm on the right
Alignment	Align to the left hand side inclusive of headings
Paragraph	Keep spacing between paragraphs consistent: Two styles are acceptable:
Spacing	• Do not indent and leave a blank line between paragraphs OR
	• Indent the first line of each paragraph but leave no spaces between paragraphs
Page Numbering	All pages of the assignment must be numbered, excluding the cover page
Identification	Your name in the top right hand corner of each page
